# PROTECTING CITIZENS' ACCESS TO SOCIAL SECURITY IN CASE OF NO-DEAL BREXIT



EU citizens in the UK and UK citizens in the EU 27 will keep their social benefits acquired before withdrawal in the event of a no-deal Brexit.

The text adopted on Tuesday by the Employment and Social Affairs Committee aims to safeguard entitlements to social security benefits based on insurance, employment or residence acquired before UK's withdrawal from the EU.

These contingency measures would apply to EU citizens living in the UK and UK citizens living in one of the 27 member states who have acquired social entitlements due to the free movement of people, and guarantee they do not lose those entitlements in the event of a no-deal Brexit.

The measures will be adopted unilaterally by the EU and enter into force only if the UK leaves the EU with no withdrawal agreement in place.

MEPs also required the European Commission to draw up a report to assess how the measures have been implemented one year after application of the regulation, and submit it to Parliament and Council.

# HUMANITARIAN AID: EU ANNOUNCES OVER €161.5 MILLION FOR YEMEN CRISIS



As millions of people continue to suffer in Yemen, the European Commission has announced its intention to provide €161.5 million in humanitarian aid for 2019. This brings total Commission support for Yemen since the beginning of the crisis in 2015 to €710 million.

Announced the EU's contribution today in Geneva, at the International Conference on the Humanitarian Crisis in Yemen, Commissioner for Humanitarian Aid and Crisis Management, Christos Stylianides said: "Yemen is facing the world's worst humanitarian crisis. Four in five people are in need of assistance. With millions now threatened by famine, all must be done to deliver emergency support on the ground. For this humanitarian organisations need full access. Our new funding will allow partners to provide more food, nutrition, health services, shelter, sanitation, as well as education and protection programmes. Yet a political solution remains the only way forward. Aid alone is not the answer. This is why we fully support the efforts the UN Special Envoy Martin Griffiths and urge all parties to fully implement the agreement on Hodeidah port."

The EU has played a leading international role in mobilising support for the Yemen crisis. In 2018, EU humanitarian support reached over 14 million people in Yemen, helping the most vulnerable like women and children caught up in the conflict. The EU has repeatedly urged all parties to the conflict to respect International Humanitarian Law and prioritise the protection of civilians and civilian infrastructure. Today's conference was co-hosted by the United Nations, Sweden and Switzerland and aims to boost humanitarian response to alleviate the suffering of the most vulnerable Yemenis.

# MIGRATION AND ASYLUM: EU FUNDS TO PROMOTE INTEGRATION AND PROTECT BORDERS



MEPs backed on Tuesday increasing the EU budget for migration and asylum policies and to reinforce borders. The Civil Liberties Committee endorsed the renewed Asylum, Migration and Integration Fund (AMIF), the 2021-2027 budget of which will increase up to €9.2 billion (€10.41 billion in current prices, 51% more than in the previous financial framework). It also backed the creation of a new Integrated Border Management Fund (IBMF) and agreed to allocate €7.1 billion (€8 billion in current prices) to it.

The AMIF should contribute to strengthen the common asylum policy, develop legal migration, in line with the member states' economic and social needs, contribute to countering irregular migration and ensure effective, safe and dignified return, readmission and reintegration in non-EU countries. But it should also ensure "solidarity and fair sharing of responsibility between the member states, in particular towards those most affected by migration challenges, including through practical cooperation", MEPs state.

MEPs also want to make sure that funds can be allocated to local and regional authorities, and to international and non-governmental organisations, working in the field of asylum and migration.

The draft proposal on the renewed AMIF passed with 31 votes to 23 and 1 abstention. The new IBMF was backed by 41 MEPs, 9 voted against and 2 abstained. The full House will have to confirm its position in the first March plenary, ahead of the negotiations with the Council of the EU.

The opening ceremony of the 7th World Congress against the Death Penalty was held in the European Parliament in Brussels on 27 February.

The World Congress Against the Death Penalty, organized by ECPM (Together Against the Death Penalty) from February 26 to March 1, has been the world's leading abolitionist event and brought together over 1000 stakeholders from more than 140 countries.

The official opening ceremony took place in the European Parliament Chamber on Wednesday, February 27 at 10 a.m. It gathered the MEPs, high-level guests, including the EU representative for Foreign Affairs and Security Policy, Federica Mogherini and the Belgian Foreign Minister, Didier Reynders, and several government and civil society representatives, who reflected on Positive efforts in the abolition movement and address what future work should be done to convince retentionist nations to abolish the death penalty.

Faced with the most severe refugee crisis the world has seen since the Second World War, the EU managed to bring about a step change in migration management and border protection. The EU has offered protection and support to millions, saved lives, dismantled smuggling networks and brought irregular arrivals to Europe down to the lowest level recorded in 5 years. Nevertheless, more work is needed to make the EU's migration policy truly future-proof in view of a constantly evolving geopolitical context and a steady rise in migratory pressure on a global scale.

For 3 consecutive years, arrivals figures have been steadily falling, and current levels are a mere 10% of what they were at their peak in 2015. In 2018, around 150,000 irregular crossings were detected across EU external borders. But the fact that the number of irregular arrivals has been reduced is no guarantee for the future, considering the likely continuation of migratory pressure. It is therefore essential to pursue a comprehensive approach to migration management and border protection.

# EUROPEAN COMMISSION CALLS ON NATIONAL POLITICAL PARTIES TO JOIN EFFORTS TO ENSURE FREE AND FAIR ELECTIONS IN EUROPE



President Juncker proposed measures to bolster European democracy and protect free and fair elections in Europe. Ahead of the European elections, Commissioner Vera Jourová had written to national political parties calling on them to ensure transparency of political advertising, to be ready to face cyberattacks and to respect European data protection rules during the campaign.

The package of measures adopted in September aimed to bolster European democracy and protect free and fair elections in Europe. It included a series of actions addressed to national and European political parties and foundations.

The Commission also reminds political parties and campaign organisations to implement appropriate measures to be able to tackle cyberattacks and recalls their obligations concerning the protection of personal data. Political parties that do not respect data protection rules to deliberately influence or attempt to influence the outcome of European elections will be subject to new sanctions, introduced by the amended Regulation on the European political parties and foundations at the European level, which is expected to enter into force in April. Sanctions could amount to 5% of the annual budget of the European political party or foundation concerned.

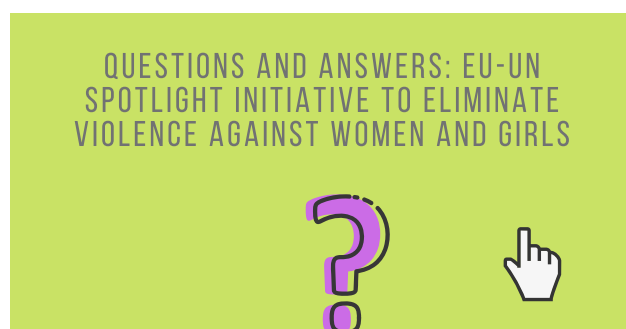
# SPOTLIGHT INITIATIVE – EU AND UN FIGHT AGAINST DOMESTIC VIOLENCE IN THE PACIFIC REGION



The European Union and the United Nations are announcing today a €50 million investment to tackle domestic violence in the Pacific region, as part of the EU-UN Spotlight Initiative. The €50 million contribution will fund new programmes to support concrete measures to end domestic and gender-based violence. It will do so by supporting preventive measures, and by providing protection and quality services to victims. Such measures will be accompanied by broader efforts to ensure women's economic empowerment and their participation in all aspects of society.

The Spotlight Initiative high-level event for the Pacific marks the beginning of a consultative process between governments, regional bodies, civil society and development partners to design a programme that seeks to end domestic violence in the region. The event brought together heads of state and government representatives from Pacific states, religious leaders, high-level representatives from the European Union and United Nations, survivors of gender-based violence, and civil society leaders to share their experiences and confirm their commitment to eliminating violence against women and girls.

# NEW ACP-EU PARTNERSHIP: EU AND AFRICA, THE CARIBBEAN AND THE PACIFIC LEADERS INTENSIFY THE REGIONAL TALKS IN SAMOA



In the context of the ongoing negotiations to modernize relations between the EU and 79 countries in Africa, the Caribbean and the Pacific (ACP), chief negotiators met with Pacific leaders last february. The talks' aim was to lay the ground for the creation of a EU-Pacific pillar, within the future agreement. The negotiators focused on the specific needs and priorities to address together in the decades to come.

In Apia, Samoa, the EU's Chief Negotiator, Commissioner for International Cooperation and Development, Neven Mimica, said: "Today's exchanges are a concrete example of how our future bilateral relations EU-Pacific, EU-Africa, EU-Caribbean, will grow deeper and stronger under the next ACP-EU agreement. We need to find new ways to fight climate change, and to protect our people and our planet. We also aim to foster blue growth in a sustainable way, and address cross border challenges together, such as human development and security issues."

Current talks mainly focus on the so-called common foundation at EU-ACP level. This contains the values and principles that bring the EU and ACP countries together. It also indicates the strategic priority areas that the two sides intend to prospectively work on together. In the future agreement, on top of the foundation there will be three action-oriented regional pillars to focus on each region's specific needs.

# EU AND OVERSEAS COUNTRIES AND TERRITORIES BOOST COOPERATION AT ANNUAL FORUM WITH €44 MILLION



At the 17th OCT-EU Forum in Papeete (Tahiti), the EU discussed its future partnership with Overseas Countries and Territories (OCTs) and signed five cooperation programmes benefiting EU OCTs, totalling €44 million. Speaking at the Forum, Commissioner for International Cooperation and Development Neven Mimica said: "As EU outposts in some of the remotest parts of the world, the EU Overseas Countries and Territories are of strategic importance for our planet's sustainable development and the biodiversity conservation in particular. Today we jointly launched new programmes to tackle climate change, increase people's living standards and create sustainable job opportunities."

The 17th annual OCT-EU Forum comes at a crucial time, as the EU reflects on its future partnership with Overseas Countries and Territories (OCTs) for the period 2021-2027. The agreements signed include an €18 million programme for climate change mitigation and sustainable energy. It will assist all EU OCTs in building up their resilience to climate change, curb disaster risks and move towards low-carbon, energy-efficient economies.

Funding of almost €4 million in Bonaire will be invested in activities and training targeted towards boosting living standards and job prospects for young people on the island.

Special measures for Sint Maarten (€7 million) and the British Virgin Islands (€2 million) will support reconstruction work in the aftermath of hurricanes Irma and Maria, which struck the Caribbean in autumn 2017.

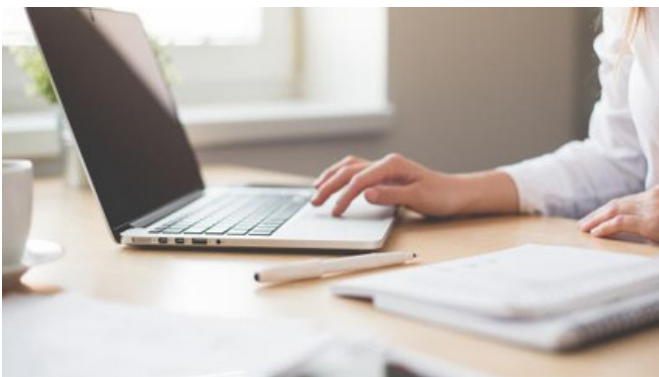

# TRAINEESHIPS AT THE COR



Each year, the Committee of the Regions (CoR) provides a limited number of internships for young citizens, from Europe and elsewhere, offering them the opportunity to acquire work experience in a European institution.

Two types of internships are available:

Each year, the CoR offers young university graduates a limited number of five-month traineeships. These training periods involve work experience in one of the Committee of the Regions' services, and run from 16 February until 15 July (spring traineeships) or from 16 September until 15 February (autumn traineeships).

Application periods:

- 1st of October to 31st March, midnight, Brussels local time, of the same year (for autumn traineeships 16th September - 15th February);

- 1st of April to 30th September, midnight, Brussels local time, of previous year (for spring traineeships 16th February - 15th July).

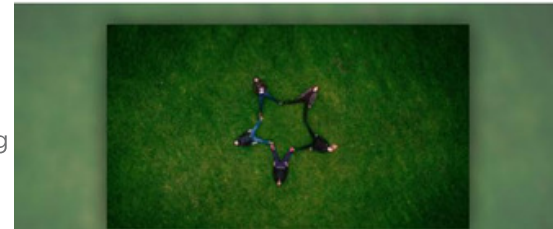
