

DATA PROTECTION REGULATION ONE YEAR ON



At the occasion of a stock-taking event to mark the first year of application of the EU General Data Protection Regulation, the European Commission is publishing the results of a special Eurobarometer survey on data protection. The results show that Europeans are relatively well aware of the new data protection rules, their rights and the existence of national data protection authorities, to whom they can turn for help when their rights are violated.

Based on the views of 27,000 Europeans, the Eurobarometer results show that 73% of respondents have heard of at least one of the six tested rights guaranteed by the General Data Protection Regulation. The highest levels of awareness among citizens are recorded for the right to access their own data (65%), the right to correct the data if they are wrong (61%), the right to object to receiving direct marketing (59%) and the right to have their own data deleted (57%).

In addition, 67% of respondents know about the General Data Protection Regulation and 57% of respondents know about their national data protection authorities. The results also show that data protection is a concern, as 62% of respondents are concerned that they do not have complete control over the personal data provided online.

Also, the European Commission organises an event bringing together national and EU authorities and businesses to mark the first year of implementation of the EU General Data Protection Regulation, in the presence of Commissioner Jourová.

A EUROPE THAT PROTECTS: GOOD PROGRESS ON TACKLING HYBRID THREATS



The European Union and Member States have made good progress in tackling hybrid threats through a number of concerted actions in a wide range of sectors to significantly boost capacities, shows the latest report adopted by the Commission and the European External Action Service.

The 22 measures identified under the 2016 Joint Framework on Countering Hybrid Threats and the 2018 Joint Communication on increasing resilience and bolstering capabilities to address hybrid threats range from improving exchange of information and strengthening protection of critical infrastructure and cybersecurity, to building resilience in our societies against radicalisation and extremism. Member States have received support through the framework, and the EU's response to hybrid threats has been successfully tested, including in a parallel and coordinated way with NATO in a number of exercises.

The report describes detailed progress in a number of areas, including strengthening strategic communications to address misinformation, cybersecurity and cyber defense, and protecting critical infrastructure, among many others.

SECURITY UNION: COMMISSION RECEIVES MANDATE TO START NEGOTIATING INTERNATIONAL RULES FOR OBTAINING ELECTRONIC EVIDENCE



EU Member States agreed to give two mandates to the Commission to participate in international negotiations to improve cross-border access to electronic evidence in criminal investigations. The Council agreed to provide the Commission with negotiating mandates for negotiations with the United States and for the Second Additional Protocol to the Budapest Convention on Cybercrime "Budapest". Both mandates include provisions on strong safeguards of fundamental rights in data protection, privacy and procedural rights of individuals, which should be an integral part of any future agreement.

Given that most criminal investigations require access to evidence online and often outside the EU, it is crucial to ensure effective cooperation and compatible standards at the international level. Recent Council decisions provide the Commission with the directives to negotiate an agreement with the US.

On the Second Additional Protocol to the Budapest Convention on Cybercrime "Budapest" of the Council of Europe, more specifically negotiations with the United States and negotiations on a second Additional Protocol to the Budapest Convention.

In both cases, the mandates require strong and specific guarantees on data protection, privacy and procedural rights of individuals based on the fundamental rights, freedoms and general principles of EU law in the Treaties and the Charter of Fundamental Rights.

Electronic evidence is needed in about 85% of criminal investigations, and in two-thirds of these investigations it is necessary to obtain evidence from online service providers located in another country. Currently, the largest service providers are based in the U.S. The number of requests to major online service providers continues to increase and grew by 84% in the period 2013-2018.

EUROPEAN BORDER AND COAST GUARD: LAUNCH OF FIRST EVER JOINT OPERATION OUTSIDE THE EU



On 21 May last, the European Border and Coast Guard Agency (FRONTEX), in cooperation with the Albanian authorities, launched the first joint operation on the territory of a neighbouring non-EU country. From 22 May, Agency teams will be deployed together with Albanian border guards on the Greek-Albanian border to strengthen border management and improve security at the EU's external borders, in full agreement with all countries concerned. This operation marks a new phase in border cooperation between the EU and its partners in the Western Balkans and is a further step towards the full operationalisation of the Agency.

While Albania remains ultimately responsible for the protection of its borders, the European Border and Coast Guard can provide both technical and operational support and assistance. European Border and Coast Guard teams will be able to support Albanian border guards in carrying out border controls at crossing points, for example, and prevent unauthorised entry. All operations and deployments at the Albanian border with Greece will be carried out in full agreement with the Albanian and Greek authorities.

Enhanced cooperation between priority third countries and the European Border and Coast Guard Agency will help to improve the management of irregular migration, increase security at the EU's external borders and strengthen the Agency's capacity to act in the EU's immediate neighbourhood, while at the same time strengthening relations.

22 MEMBER STATES SIGN NEW MILITARY MOBILITY PROGRAMME



The European Defence Agency (EDA) 22 Member States (Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, France, Greece, Hungary, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Romania, Slovakia, Spain, Sweden) have signed a new programme that will facilitate the granting of cross-border surface and air movement permissions. The programme is developed in the framework of EDA's work on military mobility. It implements an important part of the 'Action Plan on Military Mobility' which was presented by the High Representative of the Union for Foreign Affairs and Security Policy (HR) and the Commission to the European Parliament and the Council in March 2018. Military mobility is also highlighted in the EU-NATO Joint Declaration signed in Warsaw in 2016.

The purpose of the programme signed is to harmonise different national regulations of the participating Member States. It should allow Member States to reduce the administrative burden associated with different permission procedures and thus significantly shorten the timelines for granting surface and air cross border movement permissions. The programme provides the basis for important activities at technical and procedural level to develop the necessary arrangements for cross border movement per transport mode during crises, preparations for crises, training and day-to-day business. The arrangements cover surface (road, rail and inland waterways) and air movements (Remotely Piloted Aircraft Systems, fighter aircraft or helicopters). They are expected to be finalised in 2020.

EUROPEAN DEFENCE UNION: NEW GUIDANCE TO HELP MEMBER STATES RUN JOINT DEFENCE PROCUREMENTS



The European Commission has published guidance on cooperative defence procurement to help Member States apply the Defence Procurement Directive (Directive 2009/81/EC) consistently and make use of all the cooperation possibilities it offers. This will facilitate Member States' participation in collaborative defence projects under the future European Defence Fund and its current precursor programmes.

The guidance, announced in the 2016 European Defence Action Plan and in the Evaluation of the Directive, provides practical information on cooperative procurement between two or more Member States and promotes openness in defence markets, while respecting the security interests of individual Member States. In particular, the guidance clarifies the conditions for cooperative projects to be compatible with EU procurement rules applicable in the area of defence and security. The guidance complements the European Defence Fund, through which the EU provides financial support all along the lifecycle, from research to prototype development up to certification. The European Defence Fund will be fully operational in 2021. Meanwhile, EU funded defence cooperation is already materialising with precursor programmes.

For the first time in European history, under the current EU budget period, the EU is incentivising European defence cooperation with a budget envelope of €590 million. Several research projects are already underway and the Commission recently issued the first calls for projects to jointly develop defence equipment and technology covering all domains (air, land, sea, cyber and space). HOW TO STOP TERRORISM: EU MEASURES EXPLAINED



Stopping terrorism requires tackling issues such as foreign fighters, border controls and cutting off funds. Learn about the EU's counter terrorism policies.

Security is a major concern for Europeans: the vast majority (77%) want the EU to do more to fight terrorism.

EU measures to prevent new attacks run from more thorough checks at Europe's borders, to better police and judicial cooperation on tracing suspects and pursuing perpetrators, cutting the financing of terrorism, tackling organised crime, addressing radicalisation and others.

- Controls at the EU's external borders: In order to safeguard security in the Schengen area without internal borders, systematic controls were introduced in April 2017 at the external borders of all persons entering the EU, including EU citizens.

- European Air Passenger Name Record (PNR): Airlines operating flights from outside the EU and vice versa are obliged to provide national authorities with their passengers' details, such as names, dates of travel, itinerary and method of payment.

- Limiting the possession of weapons in civilian hands: The revised firearms directive closes the loopholes that allowed terrorists to use reconverted weapons, for example, in the Paris 2015 attacks. It requires Member States to have a proper monitoring system, even if exceptions are retained for hunters, museums and collectors.

10,000 EU BORDER GUARDS TO REINFORCE EXTERNAL BORDERS



MEPs have approved plans to give the EU Border and Coast Guard Agency a standing corps of 10,000 border guards by 2027 to boost Europe's security.

Europe's external borders have seen an unprecedented rise in the number of migrants and refugees wishing to enter the EU in recent years. The plans, adopted by MEPs on 17 April, will see the EU agency equipped with a standing corps of 10,000 border guards by 2027 and allow for more efficient returns in the case of non-EU nationals without a right to stay. The standing corps will consist of staff members employed by the agency as well as staff seconded on a mandatory basis by EU countries.

Maltese EPP member Robert Metsola, the MEP responsible for steering the plans through Parliament, said: "You have to be fair with those who deserve protection, harsh with those prey on the vulnerable and firm with those who seek to break the rules."

The changes aim to better manage migration, ensure the EU is able to effectively secure its external borders and provide a high level of security within the Union. The new standing corps could, at the request of an EU country, carry out border control and migration management as well as fight cross-border crime. In the event of an emergency, countries will be able to call on its rapid reaction pool for assistance.


Next steps

Once the Council has also approved them, the new rules will enter into force 20 days following their publication in the EU's official journal. The new standing corps will be available for deployment from 2021.

EU STRENGTHENS ITS SUPPORT TO STABILISATION IN AREAS LIBERATED FROM DA'ESH IN NORTH-EASTERN SYRIA



The European Union has adopted a new €18 million programme to support stabilisation work in liberated areas of Da'esh by the Global Coalition in northeast Syria. The new programme will contribute to the provision of basic services, such as water supplies and demining, within the governorates of Raqqa and Deir Ez-Zor.

The war in Syria, one of the world's worst humanitarian crises since World War II, continues to have devastating and tragic consequences for its population. It is also having an increasingly destabilising impact on the wider region, through the displacement of people, the exacerbation of political and sectarian differences and the spread of terrorism.

The European Union therefore intends to alleviate this situation through the new economic aid programme. This programme is funded by the Instrument for Stability and Peace and will complement the ongoing humanitarian and stabilisation efforts of the European Union, EU member states and other Global Coalition partners. This Instrument was established as an EU instrument to support stabilisation initiatives and peace-building activities in partner countries, the Instrument contributing to stability and peace (IcEP) finances activities in the areas of:

- crisis response,
- conflict prevention, peacebuilding and crisis preparedness;
- as well as responding to global, trans-regional and emerging threats.

IcEP activities are implemented in partner countries around the world, in conflict zones, in post-conflict environments and in emerging crisis situations. IESP actions thus contribute to an integrated approach to conflict, one of the main objectives of the EU's Global Strategy for Foreign and Security Policy.

As the conflict in Syria has entered its ninth year with continued suffering and a severe humanitarian crisis, the liberation of the provinces in northeast Syria from Da'esh by the Global Coalition is an important step towards eliminating the threat of terrorist organisation in the country, region and remains a priority for the European Union.

EXCHANGING CRIMINAL RECORDS: EU AGREES A REFORMED ECRIS SYSTEM



The EU is introducing new rules to improve the way member states exchange information on convictions of third country nationals. The reformed European criminal records information system (ECRIS) will now include a centralised database with information on convictions of third country nationals and stateless persons (so-called ECRIS-TCN).

The Council formally has adopted recently the ECRIS package consisting of a regulation and a directive. This marks the end of the legislative process.

The regulation lays down the rules for the creation of the centralised system and specifies the data to be included and the rights of access. The centralised system will include necessary data to identify a person and will cover information relating to third country nationals but also dual EU/third country nationals. The information on the conviction itself can still only be obtained from the convicting member state.

The regulation also sets out the division of responsibilities between the member states and eu-LISA, the agency which is tasked with developing and operating the system.

Next steps

This formal votes marks the end of the legislative process. The regulation and the directive will now be formally signed and then published in the official journal.

As indicated in the regulation, it will be to the Commission to define the date from which the ECRIS-TCN system will be operational once initial preparations by member states and eu-LISA have been completed.

Background

The ECRIS “package” is composed of a regulation, which establishes a centralised system to identify the member state(s) which may hold conviction information on a third country national, and a directive, which amends the existing framework decision on ECRIS in light of this new centralised system for information on third country nationals. ECRIS was established in 2012. It enables the efficient exchange of information between member states regarding criminal convictions in the EU.
