# STRENGTHENING THE RULE OF LAW THROUGH INCREASED AWARENESS, AN ANNUAL MONITORING CYCLE AND MORE EFFECTIVE ENFORCEMENT



On the basis of experience since 2014 and detailed consultations since April this year, the Commission has decided on a series of measures to strengthen the rule of law in the EU. Over the last five years, the European Commission has faced a number of challenges related to the rule of law in the European Union. The European project depends on constant respect for the rule of law. It is a prerequisite for citizens to enjoy their rights under EU law and for there to be mutual trust between Member States.

According to a recently published Eurobarometer public opinion survey, more than 80% of citizens attach great importance to respect for the rule of law and consider that it should be improved. 89% of citizens consider it necessary to respect the rule of law in all other EU Member States.

The Commission has presented concrete initiatives grouped around three pillars: promoting a culture of the rule of law; preventing problems related to the rule of law; responding effectively to violations of the rule of law. As guardian of the Treaties, the European Commission plays a unique role. However, all Union institutions and Member States are responsible for ensuring respect for the rule of law as a fundamental value of our Union. On the other hand, an effective response also requires the support of civil society. The Commission calls on all these actors to take action.

To prevent rule of law problems from emerging, the Commission has decided to set up a Rule of Law Review Cycle, including an annual Rule of Law Report covering all EU Member States. For an effective common response to rule of law breaches, the Commission will continue to make full use of its enforcement powers, if early detection and prevention measures are not effective. The Commission will adopt a strategic approach to infringement proceedings, bringing cases to the Court of Justice of the EU as necessary.

# REJECTED PUIGDEMONT AND COMÍN'S REQUEST THAT THE EUROPEAN PARLIAMENT BE ORDERED TO ALLOW THEM TO TAKE THEIR SEATS



The applicants, Mr Carles Puigdemont i Casamajó and Mr Antoni Comín i Oliveres, stood as candidates in the elections to the European Parliament on 26 May 2019. On 26 May 2019, the coalition Lliures per Europa (Junts), led by the plaintiffs, obtained 1,018,435 votes and won two seats in the European Parliament.On 13 June 2019, the Spanish Central Electoral Board adopted an Agreement, published on 14 June 2019, which proceeded to the proclamation of elected Deputies, the proclamation being subject to contentious-electoral appeal. The Board also established in this Agreement the date of the session in which the elected candidates had to take an oath or promise to abide by the Constitution.

On 20 June 2019, the Spanish Central Electoral Board sent a letter to the European Parliament notifying it of a resolution adopted by that Board and informing it that the petitioners would not acquire the status of members of the European Parliament [...] until they swore or promised to abide by the Spanish Constitution. The President of the European Parliament sent a letter to the complainants on 27 June 2019, informing them of the content of the letter sent by the Spanish authorities and informing them that, until he received further news from those authorities, he could not treat the complainants as future members of the European Parliament. On 28 June 2019, the applicants filed an application for interim measures requesting the President of the General Court - until the merits of the main action brought on the same day were decided - to suspend the execution of a series of European Parliament decisions relating to the results of the European Parliament elections of 26 May 2019 officially declared by Spain, and to order that institution to take all necessary measures to enable the applicants to take their seats in the European Parliament from the constitutive session to be held after the elections on 2 July 2019.

The President, after examining EU law governing the election of representatives to the European Parliament (1976 Act), considered that the application for interim measures could not succeed, and was therefore dismissed.

# NEW RULES AND GUARANTEES IN CRIMINAL PROCEEDINGS NOW APPLY ACROSS THE EU





The Directive on special safeguards for minors entered into force on 11 June. In addition to these new rights for minors, the Directive guaranteeing access to legal aid came into force on 5 May.

This package of EU rules ensures that the fundamental rights of EU citizens to fair and equal treatment are respected in criminal proceedings and applied in a similar way in all Member States. The following rights now apply:

Special safeguards for children. Every year more than one million minors face criminal proceedings in the EU. Children are vulnerable and need special protection at all stages of the proceedings. Thanks to the new rules that come into force today, minors will be assisted by a lawyer and will be separated from adults during detention if they go to prison. Privacy must be respected and audiovisual or any other appropriate means will be used to record interrogations. Right to legal aid. Suspected or accused persons have the right to legal aid, i.e. financial aid, for example, if they do not have the means to meet the costs of the proceedings.

#### Next steps

Member States that have not yet transposed the rules should do so as soon as possible. The European Commission will continue to work closely with Member States to ensure the correct application of these rules for the benefit of their citizens, including by organising workshops and expert meetings.

# NORMAS SOBRE EL ASILO DE LA UE: REFORMA DEL REGLAMENTO DE DUBLÍN



The arrival of migrants and asylum seekers in the EU in recent years has shown that a fairer and more effective policy is needed.

Migration flows to the EU observed in 2015 and 2016 have decreased. However, Europe, due to its geographical position and stability, can remain a recurrent destination for asylum seekers and migrants experiencing international and internal conflicts or facing climate change and poverty.

The Union needs to modernise its asylum rules and the so-called "Dublin Regulation" in particular to be more effective when receiving migrants. The reform must ensure greater solidarity, as well as a fairer sharing of responsibilities between member countries.

Keys to the EU asylum system The cornerstone of the EU asylum system is the Dublin Regulation, which determines which Member State is responsible for processing applications for international protection. Until now, the country of entry into the Union had to be in charge, which put partners with an external border in a delicate situation.

On 6 November 2017, the European Parliament confirmed its position for the Member States to reach an agreement on the modernisation of the so-called "Dublin Regulation". According to the UN Refugee Agency (UNHCR) 13.6 million people were forcibly displaced in 2018 due to persecution, conflict or violence. In total, there are 70.8 million displaced people in the world, 85% of whom are in developing regions.

# DATA PROTECTION: COMMISSION DECIDES TO REFER GREECE AND SPAIN TO THE COURT FOR NOT TRANSPOSING EU LAW



The European Commission has decided to refer Greece and Spain to the EU Court of Justice for failure to transpose EU rules on the protection of personal data (Directive on data protection in criminal matters, Directive (EU) 2016/680). In April 2016, the Council and the European Parliament agreed that the Directive should be transposed into national law by 6 May 2018 at the latest.

In the case of Spain, the Commission asks the European Court of Justice to impose financial penalties in the form of a lump sum of EUR 21 321 per day between the day after the deadline for transposition laid down in the Directive and the date of compliance by Spain, either the date of delivery of the judgment provided for in Article 260(3) TFEU, with a minimum lump sum of EUR 5 290 000 and a daily fine of EUR 89 548,20 from the date of the first judgment until full compliance or until the second judgment of the Court.

The protection of personal data is a fundamental right enshrined in the EU Charter of Fundamental Rights. The aim of the Directive is to ensure a high level of protection of personal data and, at the same time, to facilitate the exchange of personal data between national law enforcement authorities. The Directive lays down rules concerning the processing of personal data by the competent law enforcement authorities for the purposes of the prevention, investigation, detection or prosecution of criminal offences or the execution of criminal penalties. The Directive also ensures that the data of victims, witnesses, suspects and perpetrators are properly protected in the context of a criminal investigation. At the same time, better harmonised legislation also facilitates cross-border cooperation between police, prosecutors and judges to fight crime and terrorism more effectively across Europe. These EU rules contribute to the full realisation of an area of freedom, security and justice.

Non-transposition by Spain and Greece creates a different level of protection of citizens' rights and freedoms, and hampers the exchange of data between Greece and Spain and the Member States that did transpose the Directive. The Commission therefore opened the infringement procedure by sending a letter of formal notice to the national authorities of the Member States concerned in July 2018 and the corresponding reasoned opinions in January 2019. To date, Greece and Spain have still not notified the Commission of the adoption of the measures necessary to transpose the Directive.




