Council recently adopted revision of the so-called Brussels IIa regulationwhich sets out rules on the jurisdiction, recognition and enforcement decisions in οf matrimonial matters and matters of parental responsibility, as well as on intra-EU child abduction. One of the main objectives of the revision is to improve the current legal rules that protect children in cases of crossborder parental responsibility disputes, such as those related to custody, access rights and child abduction. The new rules amend several aspects of the existing Brussels IIa regulation and foresee in particular:clearer rules on the child to the opportunity for his/her views with express introduction of an obligation to give the child a genuine and effective opportunity to express his/her views;the complete abolition o f exequatur for all decisions in matters of parental responsibility. SECURITY OF 5G NETWORKS: EU MEMBER STATES COMPLETE NATIONAL RISK ASSESSMENTS



Commission Following the Recommendation for common а European approach to the security of 5G networks, 24 EU Member States have now completed the first step and submitted national risk assessments. These assessments will feed into the next phase, a EU-wide risk assessment will be completed October. National risk assessments include an overview of: the main threats and actors affecting networks.

The degree of sensitivity of 5G network components and functions as well as other assets; and various types of vulnerabilities, including both technical ones and other types of vulnerabilities, such as those potentially arising from the 5G supply chain.

Based on the information received, Member States, together with the Commission and the EU Agency for Cybersecurity (ENISA), will prepare a coordinated EU-wide risk assessment by 1 October 2019.

In parallel, ENISA is analysing the 5C threat landscape as an additional input. By 31 December 2019, the NIS Cooperation Group that leads the cooperation efforts together with the Commission will develop and agree on a toolbox of mitigating measures to address the risks identified in the risk assessments at Member State and EU level.

Fifth generation (5G) networks will form essential digital infrastructure in the future, connecting billions of objects and systems, including in critical sectors such as energy, transport, banking, and health, as well as industrial control systems carrying sensitive information and supporting safety systems.

The European Commission recommended on March 2019 a set of concrete actions to assess cybersecurity risks of 5G strengthen networks and to measures, following preventive the support from Heads of State or Government for а concerted approach to the security of 5G networks.



HOW DOES THE FIGHT AGAINST FOREST FIRES WORK IN EUROPE?



Every year there are devastating forest fires in Europe, destroying thousands of hectares of forests. Although the South European countries are at a higher risk, no European country is immune. When a forest fire gets too big for a country to extinguish it on its own, the European Union's Civil Protection Mechanism can be activated, upon request, to ensure a coordinated response.

Preparatory and monitoring measures for the 2019 forest fire season

The European Commission is reinforcing monitoring and coordination capacities to prepare for the forest fire EU's 24/7 Emergency season. The Response Coordination Centre (ERCC) will be reinforced with a forest fire support team, with experts from the Member States during the summer. National and European monitoring services and tools such as the European Fire Information Forest System (EFFIS) provide an overview of the data that European countries collect through their national forest fire programmes. Regular meetings with all Participating States in the EU Civil Protection Mechanism before the forest fire season in order to have an exchange information on the preparedness.


The EU's Copernicus Satellite system will be used to map forest fires emergencies. Several field exercises on forest fires were held in the past months. This included MODEX field exercises for civil protection on forest fires, with experts rescue teams from various EU countries and table top exercises. In addition, regular meetings with all the Participating States in the EU Civil Protection Mechanism before and during the forest fire season. This helps to have an exchange of information on the state of preparedness and fire risks. Also experts from the Participating States in the EU Civil Protection Mechanism are seconded to the ERCC every summer.

The EU Civil Protection Mechanism strengthens cooperation between Participating States in the field of civil protection, with a view to improving prevention, preparedness and response to disasters. Through the Mechanism, the European Commission plays a key role in coordinating the response to disasters in Europe and beyond.





TOWARDS EUROPEAN MILITARY DIVING TRAINING STANDARDS



Diving operations involving navies from different EU Member States are still almost impossible because there are no common European diving standards allowing such cooperation so far. This lack of interoperability has led to a serious shortage of rescue vessels and divers, which are indispensable assets in all national and international naval operations.

To enable cooperation and improve interoperability between Member States' military diving squadrons, the Project team Naval Training launched in 2012 a "Naval Training Support Study" (NTSS), focusing on three aspects: navigational training, naval warfare against mines and diving training. The aim of this study, the results of which were presented in 2014, was to provide an overview of capabilities, existina to possible common requirements, to derive deficiencies on the basis of a analysis and to propose recommendations to address them. With regard to the training of divers, the study made а number recommendations.

including establishing a doctrine on diving military (starting air/navigator diving), establishing shared divina regulation to operational needs, standardising training and operational qualification criteria common and having а certification process for diving centres. A follow-up to the NTSS study (phase 2) commissioned in 2017 completed in December 2017. It provided, inter alia, a comprehensive set of data and analysis of Member States' national diving rules, a list of common requirements for ship divers and minimum qualification standards for military divers. The results were presented to the EDA Naval Training Project team in January 2018. Based on the extended NTSS study and the conclusions of a diving workshop held in La Spezia (Italy) in September 2017, the EDA launched a new project in spring 2018 to design and implement a course module to harmonise European standards and practices for shipboard diving and shipboard rescue. The overall objective is the identification, recognition and mutual certification of EU common military diving standards.



20 YEARS OF EU SECURITY AND DEFENCE: STABILISING OUR NEIGHBOURHOOD, PROVIDING SECURITY AT HOME



In 1999, the EU's Member States decided to create a common European policy on security and defence. European security and defence has now turned 20 and much progress has been achieved, in particular over the past few years. In a rapidly changing world, the EU and its Member States are actively engaged to provide stability in our neighbourhood and security within our borders. Work continues and is needed to consolidate this progress.

In an increasingly complex and controversial world, security challenges have emerged or been strengthened: cyberattacks, hybrid threats, terrorism, hostile communication and disinformation campaigns or classic military challenges. No EU Member State can tackle these threats alone and the EU must be a credible global security provider to protect its citizens.

In 1999, the Heads of State or Government of the EU Member States met at the Cologne European Council and decided to create a common EU approach to security and defence.

On the 20th anniversary of the creation of a common European security and defence policy, much progress has been made.

To date, a total of 34 missions and operations have been deployed under a European flag. 16 of them - 10 civilian missions and 6 military missions and operations - are currently active in our neighbourhood: Africa, the Western Balkans and Eastern Europe, the Middle East. More than 4,000 European women and men are engaged on the ground to stabilise our partner countries and work for security at home.

Unprecedented progress has been made in recent years: Permanent structured defence cooperation for joint work on new capabilities and better interoperability of existing ones; new tools and financing instruments for a stronger and more competitive European defence industry, more efficient spending and better capabilities; better command structures for EU international civil and military missions and operations.

THE EU STEPS UP SUPPORT TO PREVENT VIOLENT EXTREMISM AND RADICALISATION IN CENTRAL ASIA



The European Commission has this week allocated additional € 4 million civil support the media, society organizations and active citizens Kazakhstan. Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan to prevent violent extremism and counteract radicalization.

The new projects will support the training and professionalization of local journalists, activists and press officers to produce high quality content, while fact verification platforms will be created to mark false news. The action, through the Instrument that contributes to Stability and Peace, also contributes to combat disinformation, increases the resilience of the local population and minorities, and develops counter-narratives.

The announced support will consolidate and allow the progress of the activities initiated through a previous collaboration with the NGO Internews, promoting regional collaboration and the coproduction of content related to peace and stability.

Context

Very often, extremist groups use online channels to promote ideologies that incite the most vulnerable in society, including young people, to violence. This has resulted in the dissemination of misinformation and biased opinions on sensitive social, political and religious issues that can be easily exploited.

In this context, the EU-supported project "Contributing to stability and peace in Central Asia through media literacy, information enhancement and regional cooperation" has sought to increase the capacity of local journalists, activists and press officers to produce high quality content while encouraging more critical reading of the news. RECENT EU PLANS IN DEFENCE ENTAIL PERFORMANCE



Member States' current military capabilities and cooperation do not match the new level of ambition of the EU's defence policy, according to a new review by the European Court of Auditors. Synergies between EU initiatives and other defence and security frameworks are essential, warn the auditors. In particular, a critical point is whether the EU will be able to complement NATO and avoid duplication and overlapping. However, recent initiatives at EU level and the proposed increase in funding entail performance risks.

Member States remain strongly in the driving seat when it comes to European defence and, until 2014, there had only been limited action at EU level. However, recent international developments, coupled with economic and industrial considerations, have given European defence cooperation new momentum. Following the 2016 EU Global Strategy and its implementation plan on security and defence, several initiatives and mechanisms have been launched. In this context, the European Commission proposed a marked increase in the EU budget for defence and external security: €22.5 billion for 2021-2027, compared to €2.8 billion for the 2014-2020 period.

The auditors see a risk that proper control systems may not be in place to accommodate such an increase in EU spending.

They also acknowledge that defence is a domain which lies at the heart of national sovereignty. There appear to be clear strategic differences across EU Member States, whose perceptions of security threats and vision of the EU's role in defence may differ. Member States also have different rules of engagement and a wide range of views on the use of military force. In such a context, some concepts, such as "strategic autonomy" or "a European army", remain broad and vague, the auditors note.

They further add that it is essential to ensure the coherence of EU initiatives and synergies with other defence and security frameworks. This is particularly true where NATO is concerned, as for 22 Member States it remains the primary framework when it comes to collective defence. A critical point is whether the EU is able to complement so avoid duplicating and overlapping its functions. "Defence involves creating real military capabilities, with a clear potential to deter potential threats", Juhan Parts, the Member of the European Court of Auditors responsible for the review. "In the absence of critical success factors and without specifying clear goals, there is a risk that current EU defence initiatives remain a dead letter and end up with no outcome".

EMSA RPAS DRONE SERVICE TO BOOST MARITIME SURVEILLANCE IN CROATIA



EMSA's service of Remotely Piloted Aircraft Systems (RPAS) is now being used by the Croatian authorities to assist them in a range of coast guard related functions including vessel traffic monitoring, search and rescue, and detection and monitoring of marine pollution. The request made in February 2019 by Croatia's Ministry of the Sea, Transport and Infrastructure sees a vertical take-off and landing RPAS added to their existing surveillance mechanisms for an initial period of three months.

The RPAS comes under the control of the requesting member state which in this case specifically refers to the Maritime Rescue Coordination Centre of Rijeka, as well as the port harbourmaster and Vessel Traffic Service of Split. The RPAS will be based on the island of Brač and will be expected to carry out regular patrol flights, on-demand incident monitoring missions and specific inspection operations. The RPAS comes under the control of the requesting member state which in this case specifically refers to the Maritime Rescue Coordination Centre of Rijeka, as well as the port harbourmaster and Vessel Traffic Service of Split. The RPAS will be based on the island of Brač and will be expected to carry out regular patrol flights, on-demand incident monitoring missions and specific inspection operations.

The RPAS is a Camcopter S-100 model under contract to EMSA from Schiebel Aircraft GmbH and has several specialised features which make it particularly useful to the Croatian authorities. The aircraft can operate both during the day and night, has a maximum range of 100km and six hours operational flight time. In addition, it is equipped with high performance Wescam MX-10 optical and infrared cameras as well as an Automatic Identification System receiver, and a PT-8 Oceanwatch automated maritime surface search sensor. This sensor detects targets at sea during the day and is particularly useful in man-over-board situations. The Camcopter is also capable of detecting distress signals with its on board EPIRB sensor.

EMSA's RPAS services were set up in 2017 and have now been operational in Portugal, Spain, Iceland, Denmark and Italy. They were developed to assist in maritime surveillance and monitoring operations to support national authorities involved in coast guard functions. This includes: maritime pollution and emissions monitoring; detection of illegal fishing, anti-drug trafficking, and illegal immigration; border surveillance; and, search and rescue operations

October marks the kick-off of the European Cybersecurity Month (ECSM), coordinated by the European Union Agency for Cybersecurity (ENISA), the European Commission and supported by the Member States. This campaign will focus on expanding awareness about cybersecurity to citizens across Europe.

The 2019 campaign focuses on different themes addressing the need for behavioural change and identifying opportunities to help users recognise the risks of new technologies.

The first theme encompasses basic 'Cyber Hygiene', which uses the hygiene metaphor to inform about good cybersecurity habits that are part of everyone's daily routine. Having healthy cyber safety practices can provide users with more confidence using their devices, whether it's a computer, a smart phone, a wearable device or any other gadget that's connected to the internet. The key take-home message conveys that cyber hygiene is a habit you learn from a young age and remains a daily routine for life.


